26th Stated Meeting September 12, 2023 New England Grace Presbyterian Church, West Hartford, CT

The Korean Northeastern Presbytery held its 26th Stated Meeting on September 12, 2023 at New England Grace Presbyterian Church, 139 Vanderbilt Ave., West Hartford, CT 06110.

026-01. Opening Worship

The presbytery met for the opening service at approximately 10:56 AM. The moderator, TE Taehwan Oh opened the worship with prayer and everyone recited the Apostles' Creed together. After singing Hymn 68 (old 32), We Praise Thee, O God, Our Redeemer, Creator, TE Samuel Ki-Joong Sung led the presbytery in prayer. TE Taehun Kim of Greater Springfield Korean Church delivered a sermon entitled "The God Who Works Together" from Exodus 17:8-16. He emphasized that in the midst of God's deliverance, God trains and builds up the body of Christ with spiritual discipline, especially applicable to pastors and elders in the midst of difficult times in ministry. TE Oh gave some announcements. Then, TE Oh led the congregation in singing Hymn 210 (old 245) Glorious Things of Thee Are Spoken. TE Jabum Gu closed the worship with prayer and the benediction at 11:30 AM.

MSP to <u>approve the following response</u>: Presbytery agrees with the exception and apologizes for the lack of clarity in the minutes and will be more careful in the future. TE Bumjoon Oh was unable to respond regarding Ark Church due to some family emergencies and he is currently in Korea at the time of Presbytery. In light of the family emergencies (recently TE Oh lost his father-in-law in Korea), presbytery made the following motion: Regarding Ark Church, that they should APPEAR and RESPOND by the next Stated Meeting. **MSP**

TE Samuel Sung appeared to respond regarding Glory Community Church and promised to be more faithful in regards to meeting and submitting session records going forward. TE Daniel Chi was unable to attend but responded through multiple emails and promised to be more faithful in regards to meeting and submitting session records going forward. Regarding Glory Community Church and Beloved Presbyterian Church, the presbytery accepts the explanation and will be vigilant in following up to see future session records. **MSP**

026-17c. Water Gate Presbyterian Church of New York request to join PCA KNEP

Mr. David Suh and Rev. Jaegil Jeon presented some history regarding the church and answered some questions. Rev. Jeon had been serving the church, but as he retires, the church is in need of help, and so was in consideration of seeking a good denomination, and so, Rev. Jeon suggested his former presbytery, KNEP. The church previously started as there is a long history of Korean immigrants who had lived long in China, of whom some have found their way to New York.

MSP to approve the request of Water Gate PC of NY, an independent church, to join the PCA KNEP as a mission church. TE Taehwan Oh (convener), TE Yohan Jung, RE Hongman Choi, and RE Phil Hanwoo Bae were appointed as the interim session.

As no PCA pastor is present at the church, Rev. Jaegil Jeon, currently a member of 대한에수교 장로회 (순장) 총회, was presented as one of the regular preachers to potentially fill the pulpit, along with some other presbytery brothers. As such he was considered for licensure to preach regularly in a pulpit of a presbytery church. Rev. Jaegil Jeon was previously a member of the presbytery. He was questioned if he had any differences with the Westminster Standards, to which he responded in the negative.

Rev. Jeon was examined for Licensure:

He was asked to share his Christian experience and inward call. He was further asked questions on those as well as his views and knowledge of the Bible, theology, and BCO. He stated that he had no differences with the Westminster Standards.

He also presented a brief sermon in written and oral form on John 3:16 entitled "The Love of God Is."

After arresting the questions, the candidate was asked to step out.

Christian experience: passed

Inward call: passed Sermon: passed Bible: passed Theology: passed BCO: passed

Westminster Standards: no difference, passed



MSP to approve him for licensure in the Korean Northeastern Presbytery. The moderator then asked Rev. Jaegil Jeon to raise his right hand and affirm the questions he presented from BCO 19-3. He then made the declaration found in BCO 19-4.

At New England Grace Presbyterian Church, the 12th day of September, the Korean Northeastern Presbytery, having received testimonials commending Rev. Jaegil Jeon, proceeded to submit him to the prescribed examination for licensure, which was met to the approval of the Presbytery. Having satisfactorily answered the questions for licensure, Rev. Jaegil Jeon was licensed by the Presbytery to preach the Gospel within the bounds of this Presbytery.
