28th Stated Meeting October 8, 2024 Greater Springfield Korean Church, Agawam, MA

The Korean Northeastern Presbytery held its 28th Stated Meeting on October 8, 2024 at Greater Springfield Korean Church, 22 Hunt St, Agawam, MA.

028-01. Opening Worship

The presbytery met for the opening service at 11:40 AM. The moderator, TE Jabum Gu opened the worship with a call to worship, silent prayer and everyone recited the Apostles' Creed together. After singing Hymn 67 (old 31), *O Worship the King all Glorious Above*, TE Jisup Kim led the presbytery in prayer. TE Minyoung Lee delivered a sermon entitled "To the Mountains" from Psalm 121:1-8. He reminded the Presbytery that in the midst of struggles ministry and life, our help comes from the Lord. God is the keeper of his people and his church, and he is able to keep the promises that he has made to his people, even as he has already kept his people and his church through the person and work of Christ. TE Jabum Gu gave some announcements. Then, he led the congregation in singing Hymn 383 (old 483) *To the Hills, I Lift Mine Eyes*. TE Taehun Kim closed the worship with prayer and the benediction at 12:12 PM.
